A Legacy of Generosity: The Lasting Impact of Matt and Kym Hopwood

Some people leave behind more than memories—they leave a lasting impact on the lives of others. Matt and Kym Hopwood were two such people, known for their generosity, sense of adventure, and deep appreciation for the world around them. Though they lived life to the fullest, they also planned for the future, ensuring that their legacy would continue to support causes they cared about. One of those causes was Meals on Wheels Contra Costa, where their thoughtful bequest will provide thousands of meals to homebound seniors in need.

Matt Hopwood lived life to the fullest, embracing adventure, exploration, and generosity. Born in Livermore, California, on September 23, 1963, he was raised on the Delta in the family home on Sandmound Slough, where his appreciation for nature took root. After graduating from Liberty High School in 1981, he pursued his interest of geology at California State University, Sacramento, earning a bachelor's degree in 1988, followed by a Master of Business Administration in 2002. Matt worked as a consultant before joining AT&T, where he managed environmental compliance for Northern California for 20 years. He was eagerly anticipating his retirement when he passed away unexpectedly in 2021.

Kym Hopwood, born on May 23, 1965, in North Dakota, moved frequently with her family before settling in Concord, California, in 1979. She attended culinary school at Diablo Valley College, where she developed a love for food and hospitality. Though she later built a successful career as an insurance broker, she remained devoted to creating memorable dining experiences for family and friends. Every Thanksgiving, for 26 years, Kym meticulously planned and prepared an elaborate gourmet meal, a tradition that embodied her deep love for bringing people together through food.

Travel was a shared passion for Matt and Kym, and together they visited all seven continents, making lifelong memories. As a geologist, Matt accumulated an impressive rock and mineral collection, which he bequeathed to Sacramento State's Geology Department. He also established a scholarship fund to support students pursuing geology degrees, ensuring his love for the field would inspire future generations.

Their legacy of generosity extended beyond education. Though they did not have a direct connection to Meals on Wheels, Kym deeply valued food and hospitality. Her appreciation for the importance of proper nourishment and care for others made their bequest to Meals on Wheels Contra Costa a fitting tribute to her values. Trustee Deborah Hopwood, Matt's sister, reflected on their giving spirit:

"I feel very privileged to be their Trustee. It has put into perspective that we are not what we accumulate materially in this life, but what we give while we are here. Although Matt and Kym worked hard and spent their free time pursuing fun and adventure, they also planned for how they could give back after they were gone."

Matt and Kym thoughtfully structured their estate to support three core areas: education, religion, and food security. In addition to funding a geology scholarship and projects at their church, their bequest to Meals on Wheels Contra Costa will provide thousands of meals to homebound seniors. Their generosity will be felt for generations, ensuring that vulnerable members of the community receive the nourishment they need.
