Honoring a Visionary: Paul Kraintz's Legacy at the Heart of MOWCC

When Paul Kraintz began his career with Contra Costa County's Senior Nutrition Program, he wasn't thinking about legacy—he was thinking about the growing number of older adults who needed meals. He saw the waiting lists. He saw the limitations of government funding. And more than that, he saw what was coming: a future where the need would only grow.

Paul didn't wait for someone else to solve the problem. He studied the system, looked ahead, and built a solution that has now stood for 35 years.

In 1990, alongside Area Agency on Aging Director Robert Sessler, Paul helped create Meals on Wheels Contra Costa—a nonprofit established specifically to raise the funds needed to fill the gap in government funding and ensure that no eligible senior would be placed on a wait list due to funding. It was Paul's idea to form a separate nonprofit, and it was his vision to make sure the County, the service providers, and the senior community would all have a seat at the table.

"He was a true visionary," said Robert Sessler. "Paul took both a short- and long-term view of what was needed. His idea was to build a structure that could meet the need—not just for now, but for the future."

Paul served as Director of the Senior Nutrition Program for more than 30 years, and dedicated nearly 40 years of service to improving the lives of older adults. Thanks to his steady leadership and partnership with other advocates, what started with modest fundraising through mail appeals grew into a strong and reliable source of support. Over time, the organization added foundation support, grant funding, and legacy gifts—always evolving, always adapting.

Today, Meals on Wheels Contra Costa contributes approximately \$2 million annually toward meal costs, helping to guarantee approximately 800,000 meals each year for 3,800 homebound seniors across the county. By covering approximately 46% of the total cost of the countywide Meals on Wheels Programs, the organization has ensured that no senior is placed on a waitlist due to funding shortfalls.

"Looking back after 35 years, that's an incredibly wonderful place to be," Robert shared. "Very few programs in the country can say they've consistently met the need."

Paul passed away this year, and while his absence is felt deeply, his legacy remains steady. He left behind not just a framework for success, but an example of what happens when someone commits fully to their community. Paul didn't chase recognition—he focused on results. He believed in service, in shared responsibility, and in solving problems through practical leadership and long-term thinking.

His impact didn't stop with Meals on Wheels. Paul's lifelong dedication to his hometown of Martinez showed up in every part of his life—from his role with the Martinez Historical Society and Kiwanis Club to his time as a volunteer firefighter, poll worker, and mentor to local youth. He was a collector, a historian, a restorer of classic cars, and a lover of old movies. But above all, he was a man who believed that local action matters.

"Paul can be a role model for all of us," Robert said. "If you have a passion for something, and you're willing to put in the time and effort, you can have a long-lasting impact."

Honoring Paul's legacy means facing new challenges. Organizations like Meals on Wheels Contra Costa serve as a vital bridge to fill funding gaps, ensuring seniors continue to receive the meals they need. If federal funding cuts occur in the future as threatened, your support will be more important than ever. Paul's vision reminds us that local action and investment are key to guaranteeing no senior is left behind—even in uncertain times.

As we mark 35 years of Meals on Wheels Contra Costa's existence, we do so with pride and gratitude. We are here because Paul had the foresight to act. Looking ahead, we carry his example with us - his legacy alive in the mission that continues every day.
